WHEREAS

- A. The first party, Dr. B.R. Ambedkar Open University is the University, initially known as Andhra Pradesh Open Univeristy, set up on 26th August 1982 through an Act of the A.P State Legislature (APOU Act 1982). Subsequently, the University was renamed as Dr. B.R. Ambedkar Open University on 26th October 1991 by the Government of Andhra Pradesh. The establishment of this University, the first of its kind in India, heralded an era of affirmative action on the part of the Government of Telangana to provide opportunities of higher education to all sections of the society to meet the changing individual and social needs. All the programs offered by the University are recognized by the University Grants Commission (UGC), New Delhi. The motto of the University is “**EDUCATION FOR ALL**” BRAOU, established under APOU Act, 1982 as amended in 1992 has the mandate of catering to the needs of the country with the objective of democratizing higher education by taking it to the doorsteps of the learners irrespective of their age, region or formal qualifications.
- B. Swamy Ramananda Tirtha Rural Institute (SRTRI) was established by the erstwhile Government of Andhra Pradesh in 1995 vide G.O.Ms.No.28/Edn. (UE II-I) Department, dated 06.01.1996. Subsequently, the Institute was transferred from Educational Department to Rural Development wing of Panchayat Raj & Rural Development, Govt. of A.P, vide G.O.Ms.No. 313/Gen. Admn. (AR&T.1) Dept., dated 04.08.1998 and is presently working under aegis of Panchayat Raj & Rural Development Department, Government of Telangana.
- C. The primary objective behind setting up of this Institute is to empower rural people by providing easy access to technological, educational, training and related facilities in order to overcome their constraints and to boost their economic prosperity through capacity building. Over last two decades, the Institute had undertaken several research activities, extension works, field studies, skill development programs, collaborative initiatives, sponsored projects, information compilations and dissemination, etc.
- D. The Institute is governed by four authorities viz. General Council, Governing Body, Planning Board, and Finance Committee. Governing Body of the Institute is the principal executive body of the Institute. All the policy decisions are taken and approved by the Governing Body. The Chairman of the Governing Body, who is a full-time functionary, is also the academic head of the Institute. The Director of the Institute is the ex-officio secretary of the Institute and the head of administration.
- E. National flagship placement-linked skill training program – **Deen Dayal Upadhyaya Grameen Kaushalaya Yojana (DDU-GKY)** is being implemented by the Institute. With a target of training and placing 2250 candidates over 3-years period, the Institute initiated this program in the year 2015 and shall be completed well in the stipulated period. Of the total trained till now, more than 70% of these have been provided placement in several reputed private companies and firms. Further, good number of these set up their own micro enterprises and thus are self-employed. The courses offered under this scheme are aligned to National

Skills Qualification Framework (NSQF), assessed and certified by NCVT or Sector Skill Council. Currently, the Institute is offering 8 courses under this scheme, which are residential and with a training duration of 576 hours to 832 hours

F. In pursuance thereof, the parties have agreed to enter into this Agreement.

PURPOSE:

This MOU replaces the previous MOU signed with SRTRI on **4th September, 2024.**


The purpose of this MOU is to clarify and sort out the roles and responsibilities of all parties to initiate training programs in the selected areas as per Annexure- I to impart placement linked Skill Development and Training Program under the Deen Dayal Upadhyaya Grameen Kaushalaya Yojana(DDU- GKY) and other Sponsored Schemes for students who are pursuing under graduation and/or post-graduation courses from Dr. B.R. Ambedkar Open University.


Roles and Responsibilities of Dr. B.R. Ambedkar Open University, Hyderabad (Being the First Party)

1. Providing opportunities to the students of BRAOU to enroll for outcome based and skill-based training programs.
2. Create a registration Hyperlink to facilitate students enrolling with the University to register for skill courses offered under Deen Dayal Upadhyaya Grameen Kaushalya Yojana (DDU-GKY) and other Sponsored Schemes in SRTRI at any stage.
3. Students completing the courses under this MOU will be issued Joint Certificates.
4. Assist the second party to design promotional measures to motivate students to enroll for these courses and retention in placement.
5. BRAOU will establish a program centre at SRTRI for the benefit of students who would want to enroll for UG/PG programs at the University.

Roles and Responsibilities of Swamy Ramananda Tirtha Rural Institute (SRTRI) (Being the Second Party)

1. Second party will conduct Vocational and Skill Development Training Programs in the courses identified by BRAOU for from the list of courses offered by SRTRI (courses may change time to time as per DDU-GKY guidelines)
2. Second party will provide the faculty and Instructors for conducting the Training Programs.
3. Second party will provide the Stationary, Uniform and materials required for Training.
4. Second party will provide the syllabus, lesson plans for imparting quality training.
5. Second party will conduct periodical and final tests and issue joint certificates to the successful candidates.
6. Second party will assure placement for 70% of the candidates who complete training successfully under its rules and regulations




7. Second party will provide dormitory accommodation and standard menu for residential training at its Institute in Pochampally
8. Second party will ensure adequate laboratory infrastructure and tools with clean environment and teaching aids as required.
9. Issue certificates jointly with BRAOU to students who enroll under DDU-GKY through the portals of Dr. B.R.Ambedkar Open University.
10. Request for provision of any new or additional services from time to time will be addressed subject to the mutual agreement of the same by the parties herein on such mutually agreed terms. And any such request by BRAOU shall be in the form of Annexure and shall form part of the MOU.
11. Second party shall submit the training commencement and completion reports to the First party.
12. Second party shall provide post placement tracking support for the candidates placed for duration of 3 months.

PERIOD OF VALIDITY: This MOU shall be valid for a period of Three Years from the date of signing MOU or till the completion of Training.

IT IS MUTUALLY UNDERSTOOD AND AGREED BY AND BETWEEN THE PARTIES THAT:

1. **MODIFICATION:** Modification within the scope of the instrument shall be made by mutual consent of the parties by the issuance of a written modification, signed, and dated by all parties, prior to any changes being performed.
2. **INFORMATION OWNERSHIP:** All information provided by the First Party shall only be utilized for conducting training and placement and holds no ownership over the content prepared by Second Party, First party will in no way share OR distribute any information received with other public or private agencies, organizations and individuals.
3. **PARTICIPATION IN SIMILAR ACTIVITIES:** This instrument in no way restricts First Party from participating in similar activities with other public or private agencies, organizations and individuals.
4. **TERMINATION:** Any of the parties in writing may terminate the instrument in whole, or in part at any time before the date of expiration with a notice period of 6 weeks.
5. **NON-FUND OBLIGATION DOCUMENT:** This instrument is neither a fiscal nor a funds obligation document.
6. **ESTABLISHMENT OF RESPONSIBILITY:** This MOU is not intended to and not to create any right, benefit or trust responsibility, substantive or procedural, enforceable at law, by a party against First party or Second party.
7. **COMMENCEMENT/EXPIRATION DATE:** This instrument is executed as of the date of last signature and is effective and will cease to be operational automatically after completion of Training and Placements.
8. **AUTHORIZED REPRESENTATIVE:** By signing below, the individuals signed in this document as representatives of First party and Second party are authorized to act in their respective areas for matters related to this MOU.
