

**Memorandum of Understanding
between
Dr. B.R. Ambedkar Open University
and
Commissionerate of Collegiate Education**

This Memorandum of Understanding made on this Eighteenth day of July 2003, between Dr. B.R. Ambedkar Open University, Hyderabad having its Headquarters at Road No.46, Prof. G.Ram Reddy Marg, Jubilee Hills, Hyderabad, A.P., (hereinafter referred to as "BRAOU" or "University") which expression shall include its authorized representative of the first part;

And

The Commissionerate of Collegiate Education of the Government of Andhra Pradesh having its Headquarters at Nampally, Hyderabad, A.P. (hereinafter referred to as "Commissionerate") which expression shall include the authorized representative of the second part;

WHEREAS BRAOU established through the University Acts passed by the A.P. Legislative Assembly (1982 and 1993) has the mandate to provide access to higher education to large sections of the hitherto unreached population by democratising and deelitising higher education;

WHEREAS the University is committed to use the modern communication and satellite technologies through the methodologies of Open Distance Learning, to provide access to Higher Education across the barriers of space, time and location;

WHEREAS the University having established a network of Study Centres and Regional Co-ordination Centres is committed to make use of the existing physical and of infrastructure facilities available to optimise the utility of existing resources and through varied technologies of information dissemination;

And

WHEREAS the Commissionerate of Collegiate Education has a similar mandate to provide higher education through Government Colleges and Aided Colleges maintaining the quality of teaching learning services with conventional educational methodologies;

And

WHEREAS both the institutions having similar goals and objectives of imparting quality higher education and complementing each other in the realisation of common goals and objectives;

And


WHEREAS both the parties hereto agree that by pooling their physical, human and infrastructural resources and by working together mutually to synergise their activities would be able to draw on their mutual strengths in realising their individual and common goals and objectives to contribute to the fulfillment of their mandates;

The parties to this Memorandum of Understanding with the intention of being bound accept the following terms and conditions.


1. BRAOU approached the Commissionerate for permission to construct buildings in the premises of Government colleges to house their Regional Co-ordination Centres (RCCs) to use the modern communication and satellite technologies in the teaching-learning processes. BRAOU requested that land admeasuring 500 sq. yards be identified to construct BRAOU building to house the Regional Co-ordination Centre.
2. The location of the building and the host college will be decided with mutual consultation and the approval of the Commissionerate.
3. BRAOU would have no claim now or in future for the ownership of the land and the ownership of the land would be retained by the competent authority of the Govt. of Andhra Pradesh.
4. BRAOU would construct a building and use the finances within the budget provisions of the University. The University will equip the building with furniture and down linking facilities for tele-conferencing and provide other infrastructure facilities to have a wide area network connecting the Headquarters with the Regional Co-ordination Centre.
5. BRAOU shall ensure that the activities of RCC would not disturb the activities of the host college.
6. BRAOU would have the complete ownership of the building and the furniture, equipment and apparatus procured through University Funds.

7. BRAOU agrees to share the down linking facilities with the host college where the R.C.C. Building is located on days where the BRAOU will not be using the facilities and without detriment to the normal working of the R.C.C.
8. Any changes in these terms and conditions will be resolved through mutual consultations and consensus.

In the circumstances stated by the Vice-Chancellor, Dr. B.R. Ambedkar Open University, Hyderabad in his letters first and fourth read above and in pursuance of the orders issued by the Government in their order third read above, the Director of Collegiate Education, Andhra Pradesh, Hyderabad hereby accords approval/permission to Dr. B.R. Ambedkar Open University, Hyderabad to construct the buildings for housing its Regional Co-Ordination Centres in the premises of the following Government Degree Colleges.

1. Government Degree College for Men, Adilabad
2. SR & BGNR Government College, Khammam
3. Nagarjuna Government College, Nalgonda
4. Government Degree College, Rajahmundry
5. Government Degree College for Men, Cuddapah
6. New Government Degree College, Khairatabad, Hyderabad

The above approval/permission for construction of buildings for the Regional Co-Ordination Centres of Dr. B.R. Ambedkar Open University, is subject to the following conditions:-

1. The University shall take up the construction of the buildings for housing its Regional Co-Ordination Centres at the places identified mutually by the Colleges and the University, on a land (site) admeasuring 500 (five hundred) square yards in the premises of the above colleges.
2. The University will have no claim now or in future for the ownership of the land on which they are constructing the buildings for housing their Regional Co-Ordination Centres and the ownership of the land will be retained by the Department of Collegiate Education.
3. The University will construct the buildings with its own finances. The University will equip the building with furniture and down linking facilities for tele-conferencing and provide other infrastructure facilities to have a wide area network connecting their Headquarters with the Regional Co-Ordination Centres.

4. The University shall ensure that the activities of their Regional Co-Ordination Centres will not disturb the activities of the host (Government Degree) College.
5. The University will have the complete ownership of the building and furniture, equipment and apparatus procured through its funds.
6. The University agreed to share the down linking facilities with the host college where the Regional Co-Ordination Centre building is located on the days where the University will not be using the facilities and without detriment to the normal working of the Regional Co-Ordination Centre.

The Principals of the above Government Degree Colleges are requested to identify the place in the premises of their colleges for construction of the building for housing the Regional Co-Ordination Centres of Dr. B.R. Ambedkar Open University in consultation with the University authorities.


