

(A) Responsibilities

(a) Responsibilities of Dr. BRAOU.

- (1) The advertisement calling for applications from the eligible candidates in the prescribed form for admission into the two year Master of Business Administration (Hospital and Health Care Management) shall be released by Dr.BRAOU in the name of both Dr.BRAOU and AIHCM.
- (2) Dr.BRAOU shall prepare a list of admitted candidates and forward the same to AIHCM for conduct of the programme.
- (3) Dr.BRAOU shall prepare and shall supply to AIHCM the study material available for the MBA (Hospital and Health Care Management) Course.
- (4) Dr.BRAOU shall formulate the syllabus for MBA (HHCM) programme.
- (5) Dr.BRAOU shall conduct examinations in the premises of AIHCM in the campus of Apollo Health City and award degree along with a certificate by the Registrar of Dr.BRAOU indicating that the programme is conducted as a full time , on campus programme in collaboration with AIHCM of AHERF

(b) Responsibilities of AIHCM of AHERF

- (1) The cost of news paper advertisement is to be borne by AIHCM.
- (2) The AIHCM shall assist Dr.BRAOU in the scrutiny of applications and conduct of entrance test.
- (3) The programme shall be conducted by AIHCM at its premises in the Apollo Health City Campus.
- (4) AIHCM shall bring out at its cost the prospectus and application forms to be supplied to candidates applying for the course with names of Dr.BRAOU and AIHCM.
- (5) AIHCM shall arrange for the requisite number of Faculty at its cost to conduct classes for each subject as per the syllabus drawn up by Dr.BRAOU.

(B) General:


- (1) Both parties hereto agree that the number of candidates to be admitted into the programme shall be fixed at 60 (sixty), out of which 20 (twenty) percent of seats will be reserved for Management quota of AHERF and the remaining 80% are filled by observing the rules of reservation as applicable from time to time to Dr.BRAOU. The seats remaining, if any, under this reserved quota shall be filled by candidates from the general pool.
- (2) Both the parties hereto, agree that an amount of Rs. 1,20,000/- (Rupees One Lakh and Twenty Thousand only) shall be collected from each candidate, which shall be paid in two installments, Rs.70,000 at the time of admission and Rs.50,000 at the beginning of second year. A caution deposit of Rs. 5,000/- shall be collected from each candidate by AIHCM, which shall be refunded by AIHCM to the candidate on completion of programme.
- (3) The amount of Rs. 70,000/-(Rupees seventy thousand) of I year shall be shared by Dr. BRAOU Rs. 22,500/- (Rupees twenty two thousand five hundred only) and AHERF Rs. 47,500/- (Rupees forty seven thousand five hundred only). - (4) Both the parties hereto agree that AIHCM shall collect from each candidate an extra amount of Rs. 5,000/- to meet the expenditure of internal examinations, continuous evaluation, arranging for expert lectures, Computer Lab, Placement Assistance, Internet access, field visits, internship and other student services.
- (5) Both parties hereto agree that an **extra amount of Rs.1,50,000/- (Rupees One Lakh Fifty Thousand only)** shall be collected from Management Quota candidates in addition to the regular fees of Rs. **1,20,000/- (Rupees One Lakh Twenty Thousand only)**, which is shared between Dr. BRAOU and AHERF in the ratio of 25:75 i.e. 37500: 1,12,500 respectively.
- (6) Thus, Rs. 70,000/- shall be collected at the time of admission and Rs. 50,000/- in the beginning of second year and incase of Management Quota candidates Rs.2,20,000/- shall be collected at the time of admission and Rs. 50,000/- at the beginning of second year, by Dr.BRAOU
- (7) Both parties hereto agree that the MOU will be valid for 3 academic years, i.e. 2015-16, 2016-17, 2017-18 subject to review and modification as and when necessary. It may be renewed further by mutual consent.
- (8) Both parties here to agree that any dispute, arising out of this MOU shall be settled mutually through discussions and that in the event of their failure to settle the dispute the matter shall be referred to Arbitrator appointed by the University within the jurisdiction of twin cities of Hyderabad and Secunderabad.

- (3) The course shall be conducted by AHERF at its premises in the Apollo Health City Campus.
- (4) AHERF shall bring out at its cost the prospectus and application forms to be supplied to candidates applying for the course with names of BRAOU and AHERF.
- (5) AHERF shall arrange for the requisite number of Faculty at its cost to conduct classes for each subject as per the syllabus drawn up by BRAOU.

(B) General:

- (1) Both parties hereto agree that the number of candidates to be admitted into the course shall initially be fixed at sixty, out of which twenty percent seats will be reserved for sponsored, and NRI candidates and the seats remaining, if any, under this reserved quota shall be filled by candidates from the General Quota.
- (2) Both the parties hereto, agree that an amount of Rs. 1,20,000/- (Rupees One Lakh and Twenty Thousand) shall be collected from each candidate. A caution deposit of Rs. 5,000/- shall be collected from each candidate which shall be refunded by AHERF to the candidate on completion of course.
- (3) Both parties hereto, agree that out of the amount of Rs 1,20,000/- (Rupees One Lakh and Twenty Thousand) the fee for the MBA (Health Care Management) course shall be Rs. 1,00,000/- (Rupees One Lakh) which shall be shared by BROAU and AHERF in the ratio of 25:75 respectively.
