

Nature of Services to be provided and Payment Terms

Service: 1. M.Ed, B.Ed and B.Ed Spl. Edn. Examination Services

Procedure and payment terms

- a) BRAOU will arrange for the advertisement for M.Ed, B.Ed and B.Ed Spl. Edn. ET(Entrance Test) - 2013 in the month of May, 2013 and also provide necessary information to the candidates at the study centres, through University's Web site, and also through other media.
- b) APOnline will design the ON LINE APPLICATION^N FORMAT and DATA BASE for capturing the data of the applicants after issuing the notification, in coordination with the officers of DR. BRAOU.
- c) Authorized centres of APOnline accept BRAOU M.Ed, B.Ed and B.Ed Spl. Edn. ET - 2013 ET – 2013 applications.
- d) Citizen comes to APONLINE Franchisee for applying for Entrance Test with supporting documents.
- e) Franchisee enters the applicant details in the online Application; upload the applicant data along with the photograph and signature of the applicant.
- f) APOnline will send an SMS to the candidates who successfully registered, stating the Reference Number, so as to enable the applicants to verify their details. APOnline centres also provide a print out copy of the filled - in application form to the candidate for record purposes.
- g) APOnline shall charge amounts as given below per application towards service charges inclusive of all taxes and other expenses if any and shall be deducted by APOnline from the payables of the BRAOU.
- h) APOnline will provide user name and password to BRAOU Designated Authority to access the MIS reports and to verify the details of the applicants, centre-wise, along with the fee details.
- i) APOnline shall map the franchisee with the BRAOU Study Centers in AP

- a) Citizen comes to APONLINE Franchisee for payment of Fees
- b) The APOnline Franchisee enter the application number. The Student Fee details are fetched from the BRAOU portal viz., www.braouonline.in
- c) APOnline Franchisee collects the fees from the students and confirmation of payment is sent to BRAOU portal.
- d) BRAOU portal responds with Admission Number, status and message string.
- e) A receipt is generated and given to the student.
- f) BRAOU & APOnline will integrate the above through web services.
- g) APOnline will provide UserName and Password for the MIS Reports and can be reconciled with the BRAOU Database.
