Whereas A.P. Open University is established under the provisions of A.P. Open University Act 1982, subsequently renamed as Dr. B.R. Ambedkar Open University in October1991 where as BRAOU has been offering various Certificates, Diploma, Degree & Post Graduation Program and Research Program for the benefit of people in the various fields.

And Where as BRAOU is desirous of introducing 2 years Certificate, Diploma Programs and 3 Years Degree Program in the field of Para-Medical & Allied Health Sciences

Registered under MES under the Andhra Whereas MIMS Pradesh(Telangana Area) Public Society's Registration Act, 1350 Fasli holding Registration Number.6108/1997 with the purpose, interalia of establishing, maintaining & supporting Medical Colleges, Para-Medical, Nursing & Allied Health Colleges in Health Care with Similar Institutions for Medical & Para-Medical Education with Quality, Research in various system of Medicine.

Whereas MIMS has express its intention to BRAOU to start and associate with the Health Care Courses which are highly Job Oriented having demand both in Indian as well as at International Health Market, to provide Job opportunities for educated unemployed youth.

- The Medwin Institute of Medical Sciences is committed to provide facilities for training and research in basic and Applied Medical Sciences with the objective of developing training and Clinical technologies for the students of BRAOU for mutually agreed courses.
- The parties, being legal entities in themselves desire to sign this M.O.U for advancing their mutual interests for Training and Job Guidance for Educated Unemployed Youth in the field of Para Medical and Allied Health Courses.

Now, therefore, in consideration of the mutual promises set forth in this M.O.U .Thus both the parties has agreed to the same and agree as here under.

Clause 1: Cooperation and Objectives:

1.1 The parties are united to co-operate for common interests and objectives of providing Certificate, Diploma & Bachelor Degree courses in Health Care to the enrolled students who have completed the admission formalities of the program successfully.

MOU is for following programmes to be started from the academic year 2014-15:

- I. Certificate Programmes (Two years each year is of One Academic Year of instruction) Eligibility: - SSC pass students or equivalent.
 - a) Asst. Dialysis Technician
 - b) Asst. Emergency Medical Technician
 - c) Asst. Laboratory Technician
 - d) Asst. Radio Imaging Technician

II. **Diploma Programmes** (Two years: each year is of One Academic Year of instruction)

Eligibility: - 10+2 pass students or equivalent.

- a) Dialysis Technician
- b) Anaesthesia Technician
- c) Emergency Medical Technician.
- d) Medical Imaging Technician.
- III. Bachelor Degree Programmes (Three years each year is of One Academic Year of instruction)

Eligibility: - Intermediate or Equivalent/SSC+ 2 Year Certificate Course pass students or equivalent

a.	Bachelor in Anaesthesia Technology	(BAT)
b.	Bachelor in Medical Laboratory Technology	(BMLT)
c.	Bachelor in Medical Imaging Technology	(BMIT)
d.	Bachelor in Dialysis Technology	(BDT)
e.	Bachelor In Emergency Medical Technology	(BEMT)

1.2 There will be option of **lateral entry** for Certificate programme pass out students to enter directly into Second Year of Diploma & Diploma Passed out Candidates can directly enter in to second year of Degree programme of same stream.

Clause 2: Obligation of Dr. B R Ambedkar Open University

- 2.1 **BRAOU** shall be responsible for the whole process of admissions of students' in coordination with **MIMS**. Record maintenance, quality assurance, examination & evaluation (Academic end, Projects etc) and award of related certificates.
- 2.2 BRAOU will design the curriculum, syllabus for the courses with the help of MIMS.
- 2.3 The Dr. B R Ambedkar Open University agrees to obtain necessary approvals for the recognition of the Listed Courses from competitive authorities.
- 2.4 After completion of each Academic Year, BRAOU shall conduct final Examination in the premises of MIMS & issue the required certifications.
- 2.5 BRAOU can charge separate examination & certificate fees in addition to their fees share as per University Norms.

Clause 3: Obligation MIMS

- 3.1 Providing classrooms, technical support, computer labs, and consumables for lab experiments, hospital Postings, and other infrastructure facilities for executing the identified modules of the above programmes for both theory and Practical.
- 3.2 Providing the required qualified faculties and clinical coordinators for conducting the courses at its cost.

- 3.3 Teaching aids like the presentations, reference materials etc.
- 3.4 Designing of practical work and assignments.
- 3.5 Providing projects in-hospital and internal guidance for all the students.
- 3.6 The course material will be given to the admitted candidate's topic wise.
- 3.7 The course will be conducted by MIMS at its premises in the campus of MIMS & Clinicals will be posted in Medwin Hospitals.
- 3.8 MIMS will assist in formulating theory as well as practical confidential work for conducting final Examination. The list of Examiners & List of Paper Evaluators will be submitted to University accordingly.

Clause 4: Joint Obligations of the Parties

The parties agree to the following:

- 4.1 To define and sustain the quality and delivery of the programs.
- 4.2 Up-dating of course contents according to Healthcare Industry requirements as and when required.
- 4.3 Both the parties hereto agree that the number of candidates to be admitted in to the each course shall initially be fixed as 30 each inclusive of sponsored candidates, foreign candidates and NRI's. If the number of candidates increases above 30 in any of the course, MIMS will intimate the University to enhance accordingly for the same Academic Year.
- 4.4 If the University could not fill the candidates MIMS will issue separate advertisement along with name & Logo of BRAOU and fill the remaining seats at its own cost and the Fees will be shared accordingly as accepted.

Clause 5: Financial Terms

- 5.1 All expenses for the Advertisement of the courses connected with promotion of the programs shall be taken care by **MIMS** with the Logo & Name of BRAOU.
- 5.2 The fee shall be shared by the two parties as follows. Tuition fee is shared at ratio of 30:70 by BRAOU & MIMS respectively. BRAOU shall charge Examination fee and fee for certificates, as per university norms.
- 5.3 The BRAOU shall collect the tuition fee from time to time and arrange payment to MIMS after deduction of their share with-in a period of one month after Admissions in the form of DD in favor of Medwin Hospitals.
- 5.4 Both the parties hereto agree that the candidates will purchase their own course material, Apron, Instruments & their ID Cards supplied by MIMS.

Clause 6: Dispute Resolution

- 6.1 In the event of any dispute under this, authorized representatives of "MIMS and BRAOU" shall meet not later than seven (7) working days after receipt of notice by either party of request for dispute resolution and shall enter into good faith negotiations aimed at resolving the dispute.
- 6.2 If the representatives are unable to reach mutually satisfactory resolution of the dispute within the next fifteen (15) working days, each party shall, within seven (7) working days, designate a top management executive who will attempt, over the next fifteen (15) days, to resolve the dispute.
- In the event both the parties failed to resolve the disputes amicably, both the parties shall be entitled to approach the Vice- Chancellor of the 6.3 University for Appointment of an Arbitrator. The Sole Arbitrator appointed by the Vice-Chancellor shall enter into reference and adjudicate the disputes within the jurisdiction of twin cities of Hyderabad and Secunderabad. The award passed by the Arbitrator shall bind both the parties. The language of the arbitration proceedings shall be English only. The Provision of Arbitration and Conciliation Act shall apply to the Arbitration proceedings. The Vice-Chancellor shall have the right to replace the Sole Arbitrator in the event the Arbitrator (a) fails to enter into reference (b) refuses to proceed with the matter (c) does not hold the arbitration proceedings within three months from the date of appointment. The Sole Arbitrator shall have the right to pass interim Stephooles award.
