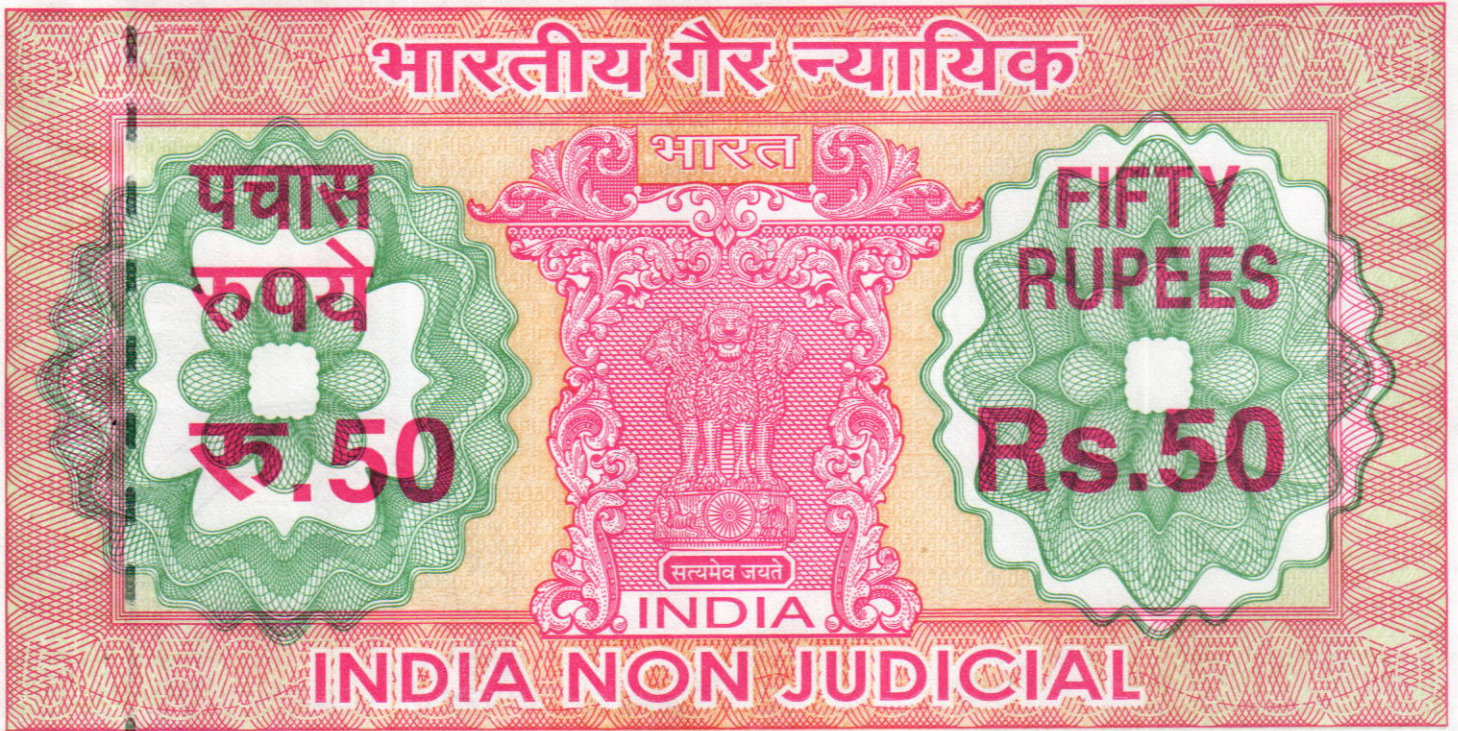

Whereas BRAOU, established under APOU Act, 1982 as amended in 1992 has the mandate of catering to the needs of the country with the objective of democratizing higher education by taking it to the doorsteps of the learners irrespective of their age, region or formal qualifications.

Whereas AOC Centre is a training institute of eminence of Indian Armed Forces designed to provide Military and Technical Training to their Recruits, Other Ranks and Junior Commissioned Officers who are responsible to provide logistic support to the Army with an overall aim to providing protection and peace to the people of India.

AOC Centre has taken upon themselves an additional objective of providing Certificate / Diploma through collaborating University with an aim to improve and upgrade educational qualifications of their Junior Commissioned Officers / Other Ranks to make them eligible and competent for a "Second Career Option" post retirement and also to enhance their employability with the corporate and other entities to fulfill the dreams and aspirations of the family members.

Keeping this in view, it is proposed to collaborate Army Ordnance Corps Centre with the University which is designed to impart technical trade training to the recruits and run various promotion cadres and conduct orientation courses for serving personnel.

Responsibilities of BRAOU

- (1) Dr.BRAOU would provide all academic inputs and administrative support for smooth conduct of the programmes.
- (2) Dr.BRAOU would actively engage in continuous monitoring of the programme right from entry through the exit.
- (3) The entire evaluation process would be the exclusive duty of the University culminating in the award of the Certificates / Diplomas after collecting the requisite fee.

Responsibilities of AOC Centre

- (1) AOC Centre would conduct the programmes at the Programme Centre located on their premises using their own resources.
- (2) AOC Centre would continuously maintain Management Information System (MIS) to facilitate exchange of information / inputs for improving the training process and its outcomes.
- (3) AOC Centre would enrich the trainee who has already left the Centre after completing the training at the AOC Centre, Secunderabad with additional inputs and bring them on par with the current batch of trainees to enable them to enroll along with the current batch for admission and examinations.

The MoU will be valid for a period of 05 years with effect from 01st June 2019 and shall be renewed from time to time at 05 years interval. However, it could be terminated anytime by either party giving notice of one academic session.

Both the parties hereto agree that any dispute arising out of this MoU shall be settled mutually through discussions.

The list of courses to be offered by AOC Centre is appended to this MoU.


