#### **WHEREAS**

- (a) The First Party, Dr. B.R. Ambedkar Open University is The University, initially known as Andhra Pradesh Open University, was set up on 26th August 1982 through an Act of the A.P. State Legislature (APOU Act 1982). Subsequently, the University was renamed as Dr. B.R.Ambedkar Open University on 26 October, 1991 by the Government of Andhra Pradesh. The establishment of this University, the first of its kind in India, heralded an era of affirmative action on the part of the Government of Telangana to provide opportunities of higher education to all sections of society to meet the changing individual and social needs. All the programmes offered by the University are recognised by the University Grants Commission, New Delhi. The motto of the University is "EDUCATION FOR ALL".
- (b) National Academy of Construction (NAC) Second Party The Second Party is an ISO 9001:2015 certified Institute. It is also a Vocational Training Provider as recognized by Government of India and also represented on the National Council for Vocational Training for one term.
- (c) NAC has eight constituent units covering all sectors of the Construction Industry. The campus has an auditorium with 500 seating capacity, seminar halls, classrooms, hostel blocks, dormitory, Quality control and testing Laboratory for construction materials, Material Display Block, Practice Ground etc. NAC has very experienced in-house faculty of 750 personnel and visiting faculty exposed to major projects.
- (d) The main aim of NAC is to impart training to unemployed youth in various construction trades and also to upgrade knowledge and skills of construction workers, engineers, contractors, managers, supervisors, Architectural Assistantship workers and inculcate professionalism in them. It has been the concern of all the parties to develop the human resource by way of imparting vocational training for manufacturing and engineering sector as per the existing demand and create avenues for suitable livelihoods and to create international standard of knowledge to produce world class workforce.
- (e) In pursuance thereof, the parties have agreed to enter into this Agreement.

#### Purpose:

The purpose of this MOU is to clarify and sort out the roles and responsibilities of all parties to initiate training programme in the selected trades as per Annexure-I to impart (03) months Placement linked Skill Development Training Programme in technical trades related to construction industry for unemployed youth who are pursuing degree studies from Dr. B.R. Ambedkar Open University.

# Roles and Responsibilities of Dr. B.R. Ambedkar Open University Hyderabad (Being the First Party)

- a. Shall mobilize the candidates and conduct pre-training counseling in collaboration with Second Party at their study center.
- b. Issue certificates jointly with NAC to students of BRAOU who complete their courses successfully.
- c. Will assist the second party in mobilizing the candidates and conducting Pre-Training Counseling pre-placement & post placement counseling in collaboration with second party to the possible extent.

## Roles and Responsibilities of National Academy of Construction (Being the Second Party)

- a. Second Party will conduct 3 months Skill Development Training Programme in trades mentioned in Annexure – I. In batches of 30 candidates per each selected trade.
- Second Party will provide the faculty like Instructors, Assistant Instructors, and Demonstrators for conducting the trades training.
- c. Second Party will provide stationary, uniform and safety gear.
- d. Second Party will provide the syllabus, lesson plans for imparting quality training.
- Second Party will conduct periodical and final tests and issue joint certificates to the successful candidates.
- f. Second Party will assure placement for 70% of candidates who completes training successfully with 80% attendance.
- g. Second Party will provide dormitory accommodation and standard menu for residential trainings at NAC training academy at Hyderabad and Jagtiyal.
- Second Party will ensure adequate laboratory infrastructure and tools with clean environment and teaching aids as required.
- Issue certificates jointly with BRAOU to students of who complete their courses successfully.

- j. Request for provision of any new or additional services from time to time will be addressed subject to the mutual agreement of the same by the parties herein on such mutually agreed terms. And any such request by BRAOU shall be in the form of Annexure and shall form part of MOU.
- Second Party shall submit the training commencement and completion reports to first party.
- Second Party shall provide Post Placement Tracking Support for the candidates placed for duration of 3 months.
- Period of Validity: This MOU shall be valid for a period of one year from date of signing MOU or till the completion of training.

# IT IS MUTUALLY UNDERSTOOD AND AGREED BY AND BETWEEN THE PARTIES THAT:

- MODIFICATION: Modifications within the scope of the instrument shall be made by mutual consent of the parties, by the issuance of a written modification, signed, and dated by all parties, prior to any changes being performed.
- INFORMATION OWNERSHIP: All information provided by First party shall only be utilized
  for conducting training and placement and holds no ownership over the content prepared by
  Second Party. First Party will in no way share OR distribute any information received with
  other public or private agencies, organizations and individuals.
- PARTICIPATION IN SIMILAR ACTIVITIES: This instrument in no way restricts First Party from participating in similar activities with other public or private agencies, organizations, and individuals.
- 4. **TERMINATION:** Any of the parties, in writing, may terminate the instrument in whole, or in part, at any time before the date of expiration with a notice period of 6 weeks.
- NON-FUND OBLIGATING DOCUMENT: This instrument is neither a fiscal nor a funds obligation document.

- 6. ESTABLISHMENT OF RESPONSIBILITY: This MoU is not intended to, and not create any right benefit or trust responsibility, substantive or procedural, enforceable at law, by a party against First party or Second Party.
- 7. COMMENCEMENT / EXPIRATION DATE: This instrument is executed as of the date of last signature and is effective and will ceases to be operational automatically on payment of last installment after completion of Training and Placements.
- 8. AUTHORIZED REPRESENTATIVES: By signing below, the individuals signed in this document as representatives of First Party and Second Party are authorized to act in their respective areas for matters related to this MOU.
