MEMORANDUM OF UNDERSTANDING (MoU)

Between

Madhya Pradesh Bhoj (Open) University, Bhopal

And

Dr. B.R.Ambedkar Open University, Hyderabad.

Madhya Pradesh Bhoj (Open) University, Bhopal, wishing to establish relation between the two institutions; agree to cooperate with each other. Subject to mutual consent, the areas of cooperation on will include any programme offered at either institution as though desirable and feasible on other side and that both sides will contribute to the fostering and development of the cooperative relationship between the two universities. Co-operation shall be carried out through such activities as:

- 1. Exchange of information: regarding publications and journals, reference materials and other results of teaching and research.
- 2. Co-operation with regard to new or existing academic programmes.
- 3. The development of joint research activities.
- 4. Staff exchange or mutual visits to both institutes.
- 5. Students training and development.
- Students Support Services and ICT services.
- 7. Advisory / Consultancy services.
- 8. Any other activities viewed to potentially beneficial.

The terms of cooperation for each specific activity implemented under this MOU for cooperation shall me mutually discussed and agreed upon in writing by both universities prior to the initiation of that activity.

The two universities hereby agree on the above articles.





MEMORANDUM OF UNDERSTANDING (MoU)

Between

And

Dr. B.R.Amhedkar Open University, Hyderabad.

Terms of Implementation Renewal, Revision

- 1. Details of the implementation of any particular exchange resulting from this MOU shall be negotiated between the two universities.
- 2. This MOU become effective on the day it is signed and will remain valid for five years.
- 3. This MOU will be renewed after five years upon the consent in writing of both universities. Each university may cancel the MOU by notifying the other University of its intent to do so least six months in advance of its expiration. Projects in progress at the time of termination will remain unaffected.
- 4. Any amendment or modification to the present text shall be submitted for review to the competent authorities, and shall not binding unless reduced to writing and signed by both the universities.
