PURPOSE:

The purpose of this MoU is to perpetuate the memory of Prof.G.Ram Reddy, the founder Vice-Chancellor of this University by promoting and undertaking activities in the field of Higher Education, Distance Education, Public Policy, Panchayat Raj and related fields which are of special interest to Prof.G.Ram Reddy.

Whereas the Trust has desired to contribute an amount of Rs.10,00,000/- (Rupees Ten Lakhs only) to the University for undertaking the Prof.G.Ram Reddy Memorial activities. The University shall make annual budgetary allocation under the Minor Head" of "Prof.G.Ram Reddy Memorial" Activities, within the Major Head which is proposed to be made in GRCR&D annual budget allocation.

Whereas, the University shall raise the funds and make request to the philanthropists and various other organization to contribute liberally and the collected amount may be kept in Fixed Deposit by the University under the name and style as "Prof.G.Ram Reddy Memorial Fund". Whereas, the interest accrued from the "Prof.G.Ram Reddy Memorial Fund" may be used for undertaking memorial activities in addition to the activities to be organized on behalf of the GRCR&D.

The University may entrust operational responsibility of undertaking memorial activities to "Prof.G.Ram Reddy Centre for Research and Development" (GRCR&D) or to any other Unit of the University as it deems fit and proper in the matter. The memorial activities may include:

- a. Annual Memorial / Endowment Lecture
- b. Prof.G.Ram Reddy Social Scientist Award
- Prof.G.Ram Reddy Research Studies may be considered and funded for Research Project.
- d. Workshops/ Seminars/ Discussion Forums/ in the field of special interest to Prof.G.Ram Reddy.
- e. Awards of Excellence for Best Research Studies/ Research Papers and Best Practices in ODL.
- f. Activities engaging students in the social transformative role of education.

Both the parties hereto agree that any dispute arising out of this MoU shall be settled mutually through discussions and that in the event of their failure to settle the dispute; the matter shall be referred to Sole Arbitrator appointed with the consent of both the parties in Hyderabad.

This MoU shall be governed by and interpreted in accordance with the laws of India and Courts at Hyderabad shall have the jurisdiction over the subject matter of dispute under this MoU.
