- 2. Create a registration Hyperlink in the online Admission Form (online Student Registration Form)to facilitate students enrolling with the University to register for skill courses (skill courses offered by NAC to be given in a drop down menu)offered by the National Academy of Construction across all its campuses (List of NAC Centers along with addresses to be given in a drop down menu)
- Issue certificates jointly with NAC to students of BRAOU who complete their courses successfully.
- 4. Assist the second party to design promotional measures to motivate students to enroll for these courses and retention in placement.
- BRAOU will explore the possibilities of collaborating with NAC to offer MBA in Real Estate Management and MBA in Construction Management programs at the University.

Roles and Responsibilities of National Academy of Construction (NAC)

- NAC will conduct Skill Development Training Programs in the courses mentioned in the Annexure – 1 (courses may change time to time as per NAC guidelines)
- NAC will provide list of Skill courses offered (by NAC) along with the eligibility criteria for each of the course and duration of each course and list of NAC Centers.
- NAC will conduct the Training Programmes as per national skill frame work curriculum providing trainers, stationery and consumables.
- 4. NAC will provide the Stationery, Uniform and materials required for Training.
- NAC will conduct periodical and final assessment and issue joint certificates to the successful candidates.
- NAC will facilitate placement for 70% of the candidates, who complete training successfully under its rules and regulations.
- 7. NAC will ensure adequate laboratory infrastructure and tools with clean environment and teaching aids as required.
- 8. Issue certificates jointly with BRAOU to students who enroll with NAC through the portals of Dr. B.R.Ambedkar Open University.

<u>PERIOD OF VALIDITY:</u> This MOU shall be valid for a period of 02 (TWO) Years from the date of signing MOU or till the completion of Training.

IT IS MUTUALLY UNDERSTOOD AND AGREED BY AND BETWEEN THE PARTIES THAT:

- MODIFICATION: Modification within the scope of the instrument shall be made by mutual consent of the parties by the issuance of a written modification, signed, and dated by all parties, prior to any changes being performed.
- 2. <u>INFORMATION OWNERSHIP:</u> All information provided by the First Party shall only be utilized for conducting training and placement and holds no ownership over the content prepared by Second Party, First party will in no way share OR distribute any information received with other public or private agencies, organizations and individuals.
- 3. PARTICIPATION IN SIMILAR ACTIVITIES: This instrument in no way restricts First Party from participating in similar activities with other public or private agencies, organizations and individuals.
- 4. <u>TERMINATION:</u> Any of the parties in writing may terminate the instrument in whole, or in part at any time before the date of expiration with a notice period of 06 (six) weeks.
- NON-FUND OBLIGATION DOCUMENT; This instrument is neither a fiscal nor a funds obligation document.
- 6. <u>ESTABLISHMENT OF RESPONSIBILITY:</u> This MOU is not intended to and not to create any right, benefit or trust responsibility, substantive or procedural, enforceable at law, by a party against First party or Second party.
