AGREEMENT


An agreement is made on this 18th Day of October, 2001 between Maulana Azad National Urdu University (MANUU), Hyderabad, represented by the Registrar of the said University and Dr. B.R. Ambedkar Open University (Dr. BRAOU), Hyderabad represented by the Registrar of Dr. B.R. Ambedkar Open University, Hyderabad.

This Agreement is renewed as per clause (7) of the earlier agreement dated 12th May, 1998 between the said parties which reads "*It can also be renewed with mutual consent by both the parties after the lapse of three years*".

Where as Maulana Azad National Urdu University desires to renew the agreement and make use of the printed Urdu medium learning materials of B.A. and B.Sc. Programmes developed by the Dr. B.R. Ambedkar Open University. The BRAOU agrees to permit the use of the printed learning materials of first, second and third year B.A. and B.Sc. Programmes on the same terms and conditions as follows.

1. The MANUU acquires reproduction rights of the Urdu medium learning materials of B.A. and B.Sc. Programmes developed by BRAOU and print the required number of copies for use by the students of MANUU.

2. In consideration of the permission, one time lumpsum amount of Rs. 30,000 (Rupees Thirty thousand only) would be paid per course by MANUU to the BRAOU for granting permission to use the printed learning materials of BRAOU for a period of three years.
3. The exclusive rights on the Urdu medium materials are reserved with the BRAOU and the MANUU does not acquire any rights except using the material for their Distance Programmes for a period of three years. The agreement does not preclude the BRAOU from its right to offer the Urdu medium courses in future. The BRAOU is also free to enter into similar MoUs with other Universities/Institutions in respect of Urdu medium courses.
4. MANUU agrees to maintain the quality and academic standards of the learning materials. MANUU also agrees to adopt the revised learning materials of BRAOU Urdu medium courses soon after the revised materials are available with BRAU.
5. Modifications, changes or enlargement of the scope of MoU, if required, could be discussed and devised by the appropriate authorities of the two Universities.
6. In case of any doubt on the interpretation of the clauses of this MoU, a joint mechanism involving the representatives of MANUU and BRAOU will look into it and take appropriate decisions.
7. This agreement is valid for a period of three years only from the date of this agreement. It may be renewed with mutual consent by both the parties after the lapse of three years.

MANUU desires to make use of the printed Urdu medium learning materials of B.A. and B.Sc. Programmes developed by the BRAOU. The BRAOU agrees to permit the use of the printed learning materials of first, second and third year B.A. and B.Sc. Programmes on the following terms and conditions.

1. The MANUU acquires reproduction rights of the Urdu medium learning materials of B.A. and B.Sc. Programmes developed by BRAOU and print the required number of copies for use by the students of MANUU.
2. In consideration of the permission, one time lumpsum amount of Rs.30,000 (Rupees Thirty Thousand only) would be paid per course by MANUU to the BRAOU for granting permission to use the printed learning materials of BRAOU for a period of three years.
3. The exclusive rights on the Urdu medium materials are reserved with the BRAOU and the MANUU does not acquire any rights except using the material for their Distance Programmes for a period of three years. The agreement does not preclude the BRAOU from its right to offer the Urdu medium Courses in future. **MEMORANDUM OF UNDERSTANDING OF INTER-INSTITUTIONAL
COLLABORATION BETWEEN THE UNIVERSITY OF HYDERABAD AND
DR. B.R.AMBEDKAR OPEN UNIVERSITY, HYDERABAD**

1. University of Hyderabad, (UoH)

1.1 The University of Hyderabad, a Central University, established by an Act of Parliament in 1974, is offering programmes in Post-graduate Teaching and Research. With effect from 1994, the University started offering programmes under distance mode also. At present, the University is offering several one year Post-graduate Diploma Programmes which are mostly innovative in nature.

1.2 The University started offering one year post-graduate Diploma programme in Human Rights with effect from 1997. The Department of Political Science which has been recognized for Special Assistance by the UGC in Human Rights, has been running this programme. The Department possesses the necessary expertise in the area of human rights. The Diploma programme evoked good response from the public. The programme focuses on Indian outlook and experience in Human Rights.

2 Dr. B.R. Ambedkar Open University (BRAOU)

2.1 BRAOU, established in 1982, was the first University in the country with the sole purpose of offering academic programmes through distance mode. The

University has been offering several programmes useful to different sections of the society and established a name for itself.

2.2 The National Human Rights Commission (NHRC) has been emphasising the need for Human Rights education. With a view to reach larger audience, the BRAOU intends to offer a Diploma Course in Human Rights in Telugu Medium. The said University approached the UoH for collaboration as it has already developed and offering a Post-graduate Diploma Programme in Human Rights.

2.3 Some of the Faculty of the BRAOU are involved in making of this Programme of the UoH and the University is aware of the quality of the study material. The BRAOU feels that this material prepared by the UoH is worth offering in the Telugu language.

3 AGREEMENT

It is hereby agreed as follows:

3.1 The UoH has agreed to provide the original study material in English relating to its present programme of the post-graduate Diploma in Human Rights (PGDHR) to BRAOU for offering a programme on Human Rights in Telugu medium on a one-time payment of Rs.3 lakhs (three lakhs only).

3.2 Every effort will be made by the BRAOU to ensure a faithful translation of the original study material. Proper mechanism would be developed by the BRAOU to see that the translation is carried out properly. The BROU may revise/update the Telugu version of the study material from time to time.

3.3 In the printed Telugu edition of the study material BRAOU will suitably acknowledge the UoH, Editors and writers of the original study material.

3.4 The BROU may use the English study material as a part of the other programmes of the University with due acknowledgements to the UoH.

3.5 The BRAOU will not transfer the rights of the original study material or its Telugu edition (or its translation to any other language) to any other third party.


3.6 If any third party desires to use the Telugu material, the terms and conditions will be as agreed by the UoH and the BRAOU.

3.7 The agreement does not preclude the UoH from its right to offer the PGDHR programme in English or any other language in future. The UoH is also free to enter into similar MOUs with other Universities/Institutions in respect of any other language including English.


3.8 Modifications, changes or enlargement of the scope of MOU, if required, could be discussed and decided by the appropriate authorities of the two Universities.

3.9 In case of any doubt on the interpretation of the clauses of this MOU, a joint mechanism involving the representatives of UoH and BRAOU will look into it and take appropriate decisions.

This Memorandum of Understanding (MOU) is entered on this 11th December 1997 between the Registrar acting on behalf of the University of Hyderabad which expression shall include his successors and assignees on the one part and the Registrar acting on behalf of Dr. B.R. Ambedkar Open University, Hyderabad which expression shall include his successors and assignees on the other part.


