

AGREEMENT

An agreement is made on this 27th day of March, 1998 between the Registrar acting on behalf of Kakatiya University (K.U.), Warangal and the Registrar acting on behalf of Dr. B.R. Ambedkar Open University, Hyderabad (BRAOU).

Kakatiya University desires to make use of the printed materials of Five courses of M.A. History (1st year four and 2nd year one course) developed by the BRAOU. The BRAOU agrees to permit the use of the printed learning materials of the above five courses on the following terms and conditions.

1. In consideration of the permission, a lumpsum amount of Rs. 50,000 (Rupees Fifty thousand only) i.e. Rs. 10,000 per course paid at one time by Kakatiya University to the BRAOU for granting permission to use the printed learning materials of BRAOU for a period of two years.
2. The BRAOU will have the exclusive right on the material and the Kakatiya University does not acquire any right except using the material for their distance programmes.
