#### Memorandum of Understanding (MoU) Between

#### **Dr. B. R. Ambedkar Open University and MEdRC EduTech Limited, Hyderabad**

THIS CONTRACT entered into on this First day of July 2003, by and between Dr. B. R. Ambedkar Open University (BRAOU) situated at Prof.G.Ram Reddy Marg, Road No.46, Jubilee Hills, Hyderabad-500 033 represented by the Registrar and MEdRC EduTech Ltd., situated at 11-5-401/2, Redhills, Hyderabad represented by P.M. Manoj Kumar, Business Development Manager.

FOR AND IN CONSIDERATION of the mutual promises and benefits to be derived by the Parties, they do hereby agree to the following:

1. BRAOU agrees to enter into a contract with MEdRC EduTech Ltd. to produce and develop a pilot project comprising 20 e-Lessons of approximately 30-minutes duration each in Course-05: Application of Information Technology of Master of Library and Information Science (MLISc) Programme.
2. It is mutually agreed that the production of the e-Lessons in the Course is to commence from First week of July 2003 and be completed by 15<sup>th</sup> August 2003 so as to enable the University to launch the e-Lesson CDs on the Foundation Day of the University, i.e., on 26th August 2003.
3. For the purpose of providing the content and faculty, BRAOU represented by Head, Department of Library and Information Science, agrees to undertake the responsibility of identifying the suitable resource persons to prepare and deliver the lectures and course content for e-Lessons and MEdRC EduTech Ltd. undertakes the responsibility of completing the production and development of e-Lessons i.e., recording of e-lessons, preparation of slides, video recording, converting into digital format, software platform, etc.
4. BRAOU agrees to identify and provide resource persons for recording w. e. f. First week of July 2003 MEdRC EduTech Ltd. agrees to complete the production & development within six weeks from the date of start of recording the e-Lessons and hand over the Master CD to BRAOU at the end of six weeks.

5. BRAOU agrees to be solely responsible to pay the resource persons the honorarium as per the approved rates for an e-Lesson of 30-minutes duration.
6. BRAOU agrees to undertake the responsibility of advising the resource persons to restructure the course units in a format to be suitable for electronic media. The entire production and development of the e-Lessons will be done in the studios of MEdRC EduTech Ltd. and the resource persons will be required to visit and spend the required number of hours of time at the studios of MEdRC EduTech Limited, Hyderabad.
7. BRAOU agrees to pay MEdRC EduTech Limited, Hyderabad the Production charges @ Rs.17, 500/- per e-Lesson of 30 minutes duration, the total cost for the 20 e-Lessons being Rs.3,50,000 (Rupees Three Lakhs Fifty Thousand only).
8. BRAOU agrees to pay MEdRC EduTech Ltd. The Production charges in four installments:
  - a. First installment : 25 % i.e. Rs.87, 500/- of the total value Production charges after the completion of first five lessons.
  - b. Second Installment: 25% i.e. 87,500/- after completion of ten lessons
  - c. Third installment : 25% i.e. 87,500/- after completion of fifteen lessons
  - d. Last and Final Installment: 25% after completion of 20 lessons and the submission of Master CD.
9. MEdRC EduTech Ltd. agrees to submit the Master copy along with the videotape of the eLessons produced within 6 weeks from the date of start of recording of eLessons.
10. It is mutually agreed between the parties that the copyright of eLessons will rest with the University.


11. MEdRC EduTech Ltd. agrees to produce eLessons in a format with University logo, signature tune, the credits, etc. as given in the video lessons of the University and submit one Master CD set to the University. The University will have right to arrange the duplication of CDs and distribution as per its requirements.

This contract is a one-time contract and is valid from the date of entering into agreement between the parties till completion and delivery of Master CD and payment of Production charges, as mutually agreed upon.

This contract is the entire agreement between the parties and can be modified with mutual consent in writing with both parties signature. This contract binds and benefits parties, their successors and legal heirs.

All suits arising out of this contract shall be instituted in a Court of Competent Jurisdiction situated in Hyderabad, State of Andhra Pradesh and in no other Court.




