

The **KSOU** is willing to provide the Soft & Hard copy of Self Learning Material in respect of Master of Arts, Education Programme to Dr.BRAOU.

NOW IT IS HERE BY AGREED AS FOLLOWS:

1. This is an agreement to use the Self Learning Materials of KSOU for an initial period of (02) two years from the date of execution of this agreement.
2. The KSOU here by grant the acquisition of reproduction and translation rights of their Study Material for distribution among the students of BRAOU.
3. The following terms and conditions govern this agreement:
 - a) KSOU will supply a soft copy and hard copy (printed by KSOU) pertaining to the programme of Master of Arts in Education to be adopted by BRAOU, to be used as a copy for further processing and printing at the cost to be borne by the BRAOU.
 - b) No change in the text shall be made when it is reprinted except for the following:
 - The print line, mentioning the name of the press where it has been printed should be substituted by a print line giving the name of the press where it is reprinted.
 - Due acknowledgement must be made for the permission to reprint given by KSOU, at a prominent place in each copy of the material.
 - The updating of data and / or error rectification maybe made with due information to the provider institution (KSOU).
 - Printing of the logo of both the Universities on the SLM must be made.
 - c) The text can be modified when the Programme is adapted with due information to the KSOU.
 - d) While using the Self Learning Printed Instruction Material, BRAOU may use Audio-Video material prepared by KSOU.
4. This agreement may be renewed by mutual written agreement of both the parties for successive additional 01 (one) year term:

6. Any breach of this Agreement shall render the license null and void :
 - i) If it is found that the BRAOU is not using the license for the given purpose.
 - ii) If it is found that the BRAOU in connivance with the Printer in selling the material in the market or making the material available to other than the enrolled learners of the BRAOU.
7. Copyrights in respect of the concerned Self Learning Material are reserved with KSOU.
8. The dispute in respect of this agreement shall be subject to the jurisdiction of Hyderabad Court only.
