About the University

The University, initially known as Andhra Pradesh Open University, was set up on 26th August 1982 through an Act of the A.P. State legislative (APOU Act 1982). Subsequently the University was renamed as Dr. B. R. Ambedkar Open University (BRAOU) on 26th October 1991 by the Govt of A.P with a vision of creating an egalitarian society. The establishment of this university, the first of its kind in India, heralded an era of affirmative action on the part of the government to provide opportunities of higher education to all sections of society with a network of RCC and Study Centres across the State to meet the changing individual and social needs. It takes full advantage of revolutionary changes in the fields of educational technology to provide and deliver multi-media course materials.

The motto of the University is Education For All. The new experiment in distance education led to opening of the portals of higher education to a variety of potential learners who would otherwise not to able to acquire new skills and higher qualifications. Thus, the University is bridging inequalities between age groups, gender and social groups in terms of educational access allowing learning to take palace parallel to work and social obligations.

The program offered range from Research Programmes to short term Certificate Programmes leading to the award of Degrees, Diplomas and certificate programs through five Faculties, such as (1) Arts, (2) Commerce, (3) Social Sciences (4) Science, and (5) Education. At present the University offers sixty-five short term, long term academic and research programmes.

About the Department

The Department established and took forward in the year1983 and taken forward by Prof. Subramanyam, Prof. Ramakrishna Reddy and Prof. E. Sudha Rani. The Department of History offers courses leading to B.A., M.A, DCHT, M.Phil., and Ph.D. Programmes. Courses designed to provide students with a broad overview of World History, Indian History and Regional History. Since its inception lakhs of learners are obtaining the knowledge as well as Degrees in history with special emphasis on socioeconomic and cultural aspects. Presently the Department is enriches with the presence of Senior Professor E. Sudha Rani, Professor Srinivas Rao Vaddanam and Associate Professor Dr G.Dayakar.

About the Conference

The English word numismatics, which owes its origin to Latin numisma (i.e., currency), 'signifies' the study of coins. The Indians of antiquity would sometimes designate the subject as Paurana-sastra, i.e., the science that dealt with the old silver currency known as the Purana. Proficiency in this branch of learning is stated to have require a study of the Rupasutra and the scrutiny of numerous coins, old and new. The student was then in a position to ascertain the significance of the symbols on the coins and to recognise the place of their origin and the artisan who was responsible for minting them.

The word numismatics is often traslted into the Neo-Aryan languages by such expressions as mudra-vidya, mudra-tattva, mudra-vijnana, etc., and therefore numismatics, as a source for the reconstruction of ancient Indian History, may be called pratna-mudra-vidya, etc., in these languages. But, since the word mudra conveys different meanings in Sanskrit, pratna-mudra-vidya, etc., may also signify the study of old seals and similar other objects. Words like rupa, rupya, etc., which are used in Sanskrit in the sense of currency, have likewise different meanings and cannot be regarded as ore suitable than mudra in this respect.

The importance of coins as a source of history is less felt in those countries where regular historical chronicles of the early period area available. But they are outstanding importance for the reconstruction of ancient Indian history, because this subcontinent did not produce in early times a Herodotus or Thucydides, a Livy or Tacitus. The coins often offer the names of persons or institutions that were responsible for their issue. Of them, only some are known from epigraphic and literary records.

The introduction of coins is landmark in the history of civilization and is great achievement of the human race. The development of trade and commerce is impossible without money, while the happiness and prosperity of human society depended largely on the ease with which one's necessities can be procured. Such problems to a great context. There several coins were found in Northern and Southern India. These coins were issued in Gold, silver, bronze, lead and other metals. The coins are important to reconstruct the history of South India. The forthcoming Conference will discuss various aspect of the study of coins in South India.

Objectives of the Conference
